# FAQ's for Community Small Grant – Rd 8

#### How do I apply for a grant?

Complete the electronic online application on Smarty Grants.

#### When can I apply for the Community Small Grants?

The Community Small Grant (CSGRd8) application, can be submitted from Monday 17<sup>th</sup> July, 2023 and closes @ 4:00 pm Friday 18<sup>th</sup> August, 2023.

#### Can a service organisation submit more than one Community Small Grant application?

Yes, if your service organisation has more than one distinct activity or program that meets the selection criteria, you can submit more than one Community Small Grant application. If 2 or more applications are submitted they should be for stand-alone projects – i.e., not two applications to receive funds to make one project viable.

Do successful Community Small Grant (CSGRd8) recipients need to report on their funding? Yes, all successful grant recipients will need to provide an end of funding financial report and a summary outcome report by July 31, 2024.

Our organisation have not previously used DEX. What support will be available to help with this? Communities for Children staff will assist at the beginning with the process of getting your organisation linked to DEX. Then your organisation will work directly with the DEX helpdesk to continue the process. #### How will we find out if we have been successful?

All applicants can expect to be notified of the outcome of their application by September 11<sup>th</sup>, 2023.

# Will Communities for Children fund an activity, event or short-term program that already exists in the Burnie Statistical Area?

Preference will be given to activities or programs that do not replicate current programs that already exist in the Burnie Statistical Area. Activities or programs that complement or expand the capacity of existing programs will be considered.

What type of activities, events or short-term programs will be supported by this small grant (CSGRd8)?

Eligible activities, events or short-term programs must fit within one (or more) of the grant focus areas below:

- Healthy families Short-term programs, events or activities targeting the 5-12 years age
  children, including outside school hours and school holiday programs or activities.
- **Early learning** Providing services or short-term programs that provide early intervention and support for children at risk of developmental and behavioural issues.
- **School transition and engagement** support children and families to make a smooth transition to primary school or high school.
- Creating strong child-friendly communities: Short-term programs, events or activities that strengthen community and family capacity and/or improve community connection and engagement for children and families pre-birth 12 years.

#### Does my application have to fit within one of the focus areas?

Yes. This is a targeted small grant round and submitted applications will need to ensure that their eligible activity, event or short-term program fits the grant focus areas.

#### Do I need to keep to the word limit?

Yes. All applicants have the same opportunity to make their case for funding. The Smarty Grants application has a word count requirement. Applications may have excess information removed or applications may not be accepted if unrequested attachments are provided.

#### Will late applications be accepted?

No. All applications must be electronically submitted through Smarty Grants by the designated closing date and time of: 4:00 pm Friday 18<sup>th</sup> August 2023. (Smarty Grants locks access after 4pm)

## How many copies must I provide?

Applications will only be accepted electronically through the Smarty Grants system. As a result, you do not need to provide any hard copies.

# Will there be an opportunity to update information after the closing date?

No

## What are my chances of receiving funding?

We don't know until the applications have been received, but our experience is that organisations with a clear objective that matches the objectives that are outlined in the documentation and have taken the time to test their idea by calling the Communities for Children team have generally been successful.

# How do I know that my application will be assessed fairly and objectively?

The Communities for Children Committee must declare any conflicts of interest and excuse themselves from involvement in decision making if any occur. The panel will be provided guidance on how to score and rank applicants so that a standardised system is used.

# Will my application be returned to me?

Applications are submitted electronically and a copy will be emailed to you once you press the submit button.
